"AN ORDINANCE ESTABLISHING RATES, RULES AND
REGULATIONS FOR WATER SERVICE BY THE
SUNNYSLOPE COUNTY WATER DISTRICT"
INDEXED - COMPARED

WHEREAS, on October 1, 1979, Ordinance No. 29 went into effect which established the connection charge in the amount of Six Hundred Dollars (\$600.00) per family unit, and

WHEREAS, since this date, actual costs to the District for water storage, supply and transmission facilities have increased, and

WHEREAS, it is necessary for the District to increase the connection charge in order to meet these increased costs,

NOW, THEREFORE, BE IT ORDAINED by the Board of Directors of the Sunnyslope County Water District as follows:

Section 1. Section 302 of Article 19 of Ordinance No. 4 as amended entitled "An Ordinance Establishing Rates, Rules and Regulations for Water Service by the Sunnyslope County Water District," passed and adopted September 8, 1955, as amended, is hereby amended by amending Section 302 thereof, to read as follows:

"Section 302. Connection Charge - Rights of Service in Existing Facilities. A connection charge for the right of service in existing and proposed and pending water supply, storage, transmission, and distribution facilities of the District shall be payable to the District for all water connections within the boundary of District. The charge shall be Eight Hundred Twenty-Five Dollars (\$825.00) per family unit."

Section 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

Section 3. This Ordinance shall be in full force and effect at 12:01 a.m. on the 30th day after its passage and shall be published once in a newspaper of general circulation published and printed in the County of San Benito, State of California, together with the names of the members of the Board of Directors voting for and against same prior to 15 days from its passage hereof.
