

ORDINANCE NO. 23

AN ORDINANCE AMENDING SECTION 7 OF ORDINANCE NO. 3 ENTITLED "AN ORDINANCE FIXING TIME AND PLACE FOR THE REGULAR MEETINGS OF THE BOARD OF DIRECTORS OF THE SUNNYSLOPE COUNTY WATER DISTRICT, AND PROVIDING THE MANNER IN WHICH SPECIAL MEETINGS OF SUCH BOARD MAY BE CALLED, DESIGNATING AN OFFICIAL MAILING ADDRESS, AND ESTABLISHING THE ORDER OF BUSINESS AND RULES FOR THE PROCEEDINGS, AS AMENDED.


BE IT ORDAINED, by the Board of Directors of the Sunnyslope County Water District, San Benito County, California, as follows:

Section 1. Section 7 of Ordinance No. 3 entitled, "An Ordinance Fixing Time and Place for the Regular Meetings of the Board of Directors of the Sunnyslope County Water District, and Providing the Manner in which Special Meetings of Such Board May Be Called, Designating an Official Mailing Address, and Establishing the Order of Business and Rules for the proceedings", adopted January 6, 1955, as amended, is hereby amended to read as follows:

"7. Mailing Address and Office. The office of the District is hereby established at 3416 Airline Highway, Hollister, California 95023, and the official mailing address is hereby established as Post Office Box 1442, Hollister, California 95023."

Section 2. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
