

ORDINANCE NO. 27

AN ORDINANCE AMENDING SECTION 9.7 (b) OF ORDINANCE NO 15 ENTITLED "AN ORDINANCE REGULATING THE USE OF PUBLIC AND PRIVATE SEWERS, THE INSTALLATION OF SEWER LATERALS AND PUBLIC SEWER EXTENSIONS, PROVIDING FOR THE EMPLOYMENT OF A SANITARY INSPECTOR, PROVIDING PERMITS AND FIXING FEES FOR THE INSTALLATION OF SANITARY SEWER LATERALS AND REGULATING THE DISCHARGE OF WATERS AND WASTES INTO THE PUBLIC SEWER SYSTEMS OF THE SUNNYSLOPE COUNTY WATER DISTRICT"

BE IT ORDAINED by the Board of Directors of the Sunnyslope County Water District, San Benito County, California, as follows:


Section 1. Subsection (b) of Section 9.7 of Article IX of Ordinance No. 15, the "Sunnyslope County Water District Sewer Regulation Ordinance," passed and adopted August 10, 1972, is hereby amended by amending Subsection (b) of Section 9.7 thereof, to read as follows:

(b) Connection Charge for Any Parcel, Unit or Lot, or Part of Said Property: A connection charge of One Hundred Seventy Dollars (\$170.00) per single-family unit of property within the boundaries of said District shall be paid by the owner or other persons desiring the connection of any such property to any sanitary sewerage system or proposed system of the District, or to any sanitary sewerage system of other persons within such area which may connect with or be proposed to be connected to any sanitary sewerage system or proposed system of said District. Said charge shall be payable for connections made on and after January 1, 1979.

Section 2. This ordinance shall take effect January 1, 1979.

Section 3. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.
